A. Determination of Quorum

The Board of Trustees Secretary, Ms. Rosario M. Lapa confirmed the quorum wherein based on the attendance and proxy forms presented we have 85% present.

B. Presentation and approval of the proposed agenda

Ms. Glenda S. Lobusta presented the proposed agenda. Having no additional agendum to be discussed, Ms. Carmen M. Aguinid, moved to approve the proposed agenda and was seconded by Ms. Flory E. Cagampang

C. Reading and approval of the minutes of the 14th Annual General Assembly

Ms. Maria Alyce A. Galenzoga, working secretary, presented the minutes of the 14th Annual General Assembly. Upon presentation, no questions and clarifications were raised from the members. Ms. Lorelyn Pallo moved for the approval of the 14th Annual General Assembly minutes, seconded by Ms. Linda Mondonedo.

D. Business arising from the 14th Annual General Assembly

There were no matters arising from the 14th Annual General Assembly minutes.

E. President's Report

Ms. Glenda Lobusta presented the 2020 Board and Management Actions as follow:

- 1. Approved the skeletal workforce system for employees during General Community Quarantine. (March 23-May 15, 2020)
- 2. Approved to extend assistance to each employees by giving 1 sack rice during GCQ.
- 3. Confirmed the additional 31 days grace period for BLIP which was directed by the Insurance Commission due to COVID pandemic.
- 4. Approved that the existing policy of the association on 45 days grace period will start on March 19, 2020 (since the last day of collection was March 18, 2020) plus the 31 days mandated by the IC which is up to June 3, 2020.
- 5. Approved the loan coverage extension of 45 days starting April 1- May 15, 2020 as per issued by the BSP, which our bank partners observed. With this, an approval for a moratorium of 45 days will be observed for CLIP premium and claims. All CLIP claim under the 45 days moratorium will be covered by the association, with an additional premium payment to be deducted during claim. However, if there is no claim, no collection on premium will be made.
- 6. A moratorium on equity loan financing for contribution payment of members not reaching 3 years of membership, but no income for the meantime due to the pandemic.
- 7. Approved the revised Good Governance Manual
- 8. Approved the amendments of By Laws and Articles of Incorporation
- 9. AMLA training for newly elected BOT and working secretary
- 10. Approved on offsetting of Equity Value of inactive members with past due equity loan of more than 1 year and nowhere to be found.
